PRIVACY POLICY FOR USERS OF EXENSIO® FREEMIUM PLATFORM AND HOSTED SERVICES

This Privacy Policy ("**Policy**") describes our practices in connection with personal information we process when you access the Platform and use the Hosted Services pursuant to the Agreement.

As the operator of the Platform and provider of the Hosted Services, PDF Solutions Semiconductor Technology (Shanghai) Co., Ltd. ("**PDF**") is the personal information processor (equivalent to data controller under GDPR) of any personal information (as defined in Section 1 below) collected or otherwise processed on or through the Platform or the Hosted Services.

Except as otherwise stated in this Policy, this Policy does not address our practices concerning information that we collect by any other means other than through the Platform or the Hosted Services; or the collection, use or disclosure of information by any of PDF's Affiliates or other third parties.

1. CATEGORIES OF PERSONAL INFORMATION COLLECTED AND PURPOSES OF PROCESSING

PDF collects the following types of personal information:

- c. Based on Consent. We may process personal information from you to optimize user experience on the Platform or the Hosted Services; to improve the Platform and the Hosted Services, and to develop new products and services.

Please note that no data transmission over the Internet or data storage system can be guaranteed to be 100% secure. Please do not send us sensitive information through email. If you have reason to believe that your interaction with us is no longer secure (for example, if you feel that the security of any account you might have with us has been compromised). you must immediately notify us of the problem by contacting us in accordance with Section 10 ("Contacting Us,") below (note that if you choose to notify us via physical mail, this will delay the time it takes for us to respond to the problem).

4. SHARING OF PERSONAL INFORMATION WITH THIRD PARTIES

The information that we ask you to provide to verify your identity will depend on your prior interactions with us and the sensitivity of the personal information at issue. We will respond to your request in accordance with the Personal Information Protection Law of the People's Republic of China ("PIPL") and other applicable laws and regulations.
